

## **Katie Taylor Homecoming Fight Ticket Presale 2026 Terms and Conditions**

### **1. The Presale Event**

- 1.1 The Lidl Plus, Katie Taylor Homecoming Fight ticket presale event (the "Presale Event") provides exclusive early access to purchase tickets for the Katie Taylor boxing match taking place at Croke Park, Dublin, Ireland on Saturday, 5th September 2026.
- 1.2 The presale event is promoted by Lidl Northern Ireland Limited (the 'Promoter') having its place of business at Dundrod Road, Nutts Corner, Co. Antrim, Northern Ireland.
- 1.3 The exclusive Lidl Plus presale window opens on Wednesday, of 10th June 2026 at 10:00 a.m. GMT and will become unavailable on Friday 12th of June 2026 at 10:00 a.m. GMT or at the time which all presale tickets are allocated, whichever event occurs first (the 'Promotion Period'). Upon conclusion of the promotion period, the access link within the Lidl Plus App will be deactivated.

### **2. Eligibility to participate**

- 2.1 Participants must be over 18 years of age, be resident in Northern Ireland and have a registered Lidl Plus account to be eligible to participate.
- 2.2 By participating in the Presale Event, participants are deemed to have accepted the Lidl Plus terms of use, these Terms and Conditions and confirmed that they meet the eligibility criteria set out in these terms and conditions. Participants are not permitted to participate on behalf of other persons and third parties.

### **3. Participation in the Presale Event**

- 3.1 To participate in the Presale Event, each participant will need to during the Promotion Period:
  - 3.1.1 **Step 1.** Install the Lidl Plus App on their smartphone or device and create a Lidl Plus account (this step shall not be required for participants who are already Lidl Plus users); and
  - 3.1.2 **Step 2.** Access the exclusive link to the Ticketmaster presale website via the link provided on the Lidl Plus App
- 3.2 There is no requirement to make a financial transaction or minimum spend in a Lidl store to access the presale event

### **4. Accessing the Presale and Ticket Purchases**

- 4.1 To access the presale event eligible participants must open their Lidl Plus App on Wednesday 10th June 2026 from 10:00 a.m. GMT to access the dedicated Ticketmaster presale link
- 4.2 The Lidl Plus App only provides the link to access the ticket pool. The actual ticket transaction, allocation and payment will occur entirely on the Ticketmaster website.
- 4.3 Access to the presale link within the Lidl Plus App does not guarantee ticket purchase or availability. Tickets are sold on a first-come, first-served basis by Ticketmaster and are subject to ultimate availability. The promoter accepts no liability if tickets sell out.
- 4.4 Tickets are not available to purchase in-store at any Lidl location. Lidl store staff cannot process ticket sales, reservation requests, or assist with Ticketmaster transaction issues.

## 5. Miscellaneous

- 5.1 The promoter acts solely as a marketing facilitator by providing access to links to Lidl Plus members. The promoter is not the ticket vendor, event organiser or venue host.
- 5.2 The promoter accepts no responsibility or liability whatsoever for:
  - 5.2.1 Technical glitches, server crashes or queuing delays on the Ticketmaster website.
  - 5.2.2 The inability of a user to secure tickets before they sell out
  - 5.2.3 Any cancellation, rescheduling or alerting of the fight card or event details by the event organiser
- 5.3 All ticket purchases are subject strictly to Ticketmaster's own Purchase Policy and Terms of Use
- 5.4 The Promoter reserves the right to cancel, terminate, modify, or suspend this Presale Event offer or vary these terms and conditions at any time without prior notice.
- 5.5 These terms and conditions shall be governed by Northern Irish law and the courts of Northern Ireland shall have exclusive jurisdiction over interpretation of same.

## 6. Data Protection

- 6.1 Lidl Stiftung & Co. KG and Ticketmaster operate as completely independent data controllers.
  - 6.1.1 Lidl Stiftung & Co. KG is solely responsible for personal data processed within the Lidl Plus app.
  - 6.1.2 Ticketmaster is independently and exclusively responsible for all personal data processed in connection with your ticket purchase, account creation and purchase transaction.
- 6.2 Lidl Stiftung does not share your My Lidl Account profile data or contact details with Ticketmaster. Ticketmaster does not return or share your payment, booking, confirmation or transaction data with Lidl Stiftung.
- 6.3 Once you click the presale link within the Lidl Plus App, you leave the Lidl Plus digital environment. Any personal data you provide thereafter is governed exclusively by Ticketmaster's Privacy Policy (available at [Privacy Policy](#)). Neither the Promoter nor Lidl Stiftung & Co. KG accepts liability or responsibility for how Ticketmaster collects, stores, secures, or processes your personal data.
- 6.4 Any data processed by Lidl Stiftung in providing access to this presale is processed on the legal basis consent which is explicitly provided on signing up to the Lidl Plus terms and conditions (Art. 6(1)(a) GDPR) and will not be transferred by Lidl Stiftung outside of the EEA.
- 6.5 Lidl Stiftung & Co. KG is the controller for the processing of personal data of the participants of the Presale Event.
